

TERMS OF AGREEMENT

Please make a copy for your records.

- The **Project Stewardship** annual fee structure of \$500 (including two parent consults - Spring and Fall) is acknowledged and agreed upon. Payments are to be made in full at time of **Project Stewardship** Program registration.
 - Other fees would include admission to outings attended (if there is a fee) which goes directly to the host organization or to The Children's Sangha for a workshop offering (if cost is incurred). Standard fees for Instructional Services, Professional Guidance or Educational Consulting are to be paid separately (based on request for individual services); sliding scale available.
 - Parents/Caregivers are
 - Parents/Caregivers are responsible for providing snack and/or lunch for volunteer opportunities and outings with The Children's Sangha or with our *Community Partners* when bringing snack/lunch is permitted.
 - Snack is provided by The Children's Sangha for our monthly meetings and workshops. Parents/Caregivers are responsible for advising on any food allergies of participants. LIST HERE:

- Parents/Caregivers are responsible for transportation to all of The Children's Sangha meetings, workshops and outings including those hosted by our *Community Partners*.
 - Permission is granted for The Children's Sangha to take and use photographs for its publicity and marketing purposes (no names used).
 - Permission is granted for all activities and experiences that are part of The Children's Sangha - **Project Stewardship** program.
 - The Children's Sangha is not responsible for any damaged, lost, or stolen property.
 - In the event of an emergency, I authorize The Children's Sangha to administer prescribed medications or obtain through emergency personnel such medical care and/or first aid as is necessary for the welfare of the young adult during **Project Stewardship** program participation.
 - I understand that my young adult will be exposed to group activities and experiences that may be new to my young adult. I accept that my young adult's participation in **Project Stewardship** activities and experiences are made in full knowledge of their inherent risks and perils.
 - I hereby guarantee my young adult's medical fitness as a prerequisite to my young adult's participation in **Project Stewardship** activities and experiences. And further, as a condition of his/her participation, I hereby agree to hold harmless severally and individually, The Children's Sangha and its employees, interns, volunteers, *Community Partners* and agents from any and all liability including prejudice of any kind whatsoever arising from my young adult's participation in the activities and experiences of **Project Stewardship**.
 - I agree that any dispute concerning, relating, arising out of or referring to the subject matter of this agreement shall be resolved exclusively by binding arbitration and the substantive laws of that state.
 - In the case that a **Project Stewardship** Participant is an adult (18 years of age or older), they are agreeing to the Terms of Agreement themselves (not for another young adult) and understand that all items listed in the Terms of Agreement apply to them. Parents/Caregivers are agreeing to the Terms of Agreement as well since responsibility may lie with parent/caregiver as guardian.
 - The Children's Sangha reserves the sole and exclusive right to dismiss **Project Stewardship** participants for improper conduct / behavior of any kind either by themselves, their siblings or parents/caregivers. Reasons would include but are not limited to: persistent incivility to staff or other participants, or misuse of materials.
