

TERMS OF AGREEMENT

- ***Student Leadership*** are seasonal volunteer opportunities with The Children's Sangha and our community partners. There is no fee for participation (except as indicated in next bullet). There is a one-year commitment when joining.
 - **Other fees** would include admission to activity attended (if there is a fee) paid directly to the host organization or the cost of food (if going out to lunch/dinner or an event where snack purchase is an option).
 - If food is involved in the activity, **parents/caregivers (or volunteers who are 18 years of age or older) are responsible for advising The Children's Sangha of their young adult's (or their) food allergies, if any. LIST HERE:**

- Parents/Caregivers (or volunteer who is 18 years of age or older) have agreed to transport their young adult (or themselves) to volunteer locations (or) has authorized permission for their young adult to transport themselves by signing this form.
 - If applicable, permission is granted for The Children's Sangha to take and use photographs for its publicity and marketing purposes (no names used).
 - Permission is granted for all activities and experiences that are part of The Children's Sangha programs, services and events as well as those of our community partners.
 - The Children's Sangha is not responsible for any damaged, lost, or stolen property.
 - In the event of an emergency, I authorize The Children's Sangha to administer prescribed medications or obtain through emergency personnel such medical care and/or first aid as is necessary for the welfare of the young adult volunteer during participation in our programs, services, and events as well as those of our community partners.
 - I understand that my young adult (or I) will be exposed to activities and experiences that may be new. I accept that my young adult's (or my) participation in The Children's Sangha activities and experiences are made in full knowledge of their inherent risks and perils.
 - I hereby guarantee my young adult's (or my) medical fitness as a prerequisite to my young adult's participation with The Children's Sangha's activities and experiences. And further, as a condition of his/her participation, I hereby agree to hold harmless severally and individually, The Children's Sangha and its employees, mentors, volunteers, community partners and agents from any and all liability including prejudice of any kind whatsoever arising from my young adult's participation in the activities and experiences offered by The Children's Sangha or their community partners.
 - I agree that any dispute concerning, relating, arising out of or referring to the subject matter of this agreement shall be resolved exclusively by binding arbitration and the substantive laws of that state.
 - In the case that a Student Leadership volunteer is an adult (18 years of age or older), they are agreeing to the **Terms of Agreement** themselves and understand that all items listed in the **Terms of Agreement** apply to them. Parents/Caregivers are agreeing to the **Terms of Agreement** for those under the age of 18 years.
 - The Children's Sangha reserves the sole and exclusive right to dismiss Student Leadership volunteers for improper conduct / behavior of any kind either by themselves, their siblings or parents/caregivers. Reasons would include but are not limited to: persistent incivility to staff or other participants, or misuse of materials.
